INVESTMENT OBJECTIVE AND STRATEGY

The objective of the fund is to achieve long-term capital appreciation via an indexing strategy based on the Philippine Stock Exchange Index (PSEI) constituents, while maintaining a reasonable level of liquidity for investor requirements.

CLIENT SUITABILITY

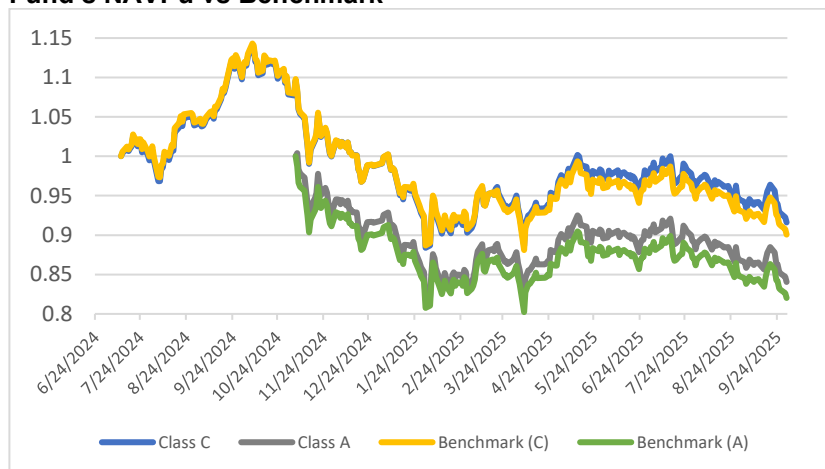

OUTLOOK AND STRATEGY

Market Review. The PSEi declined 6.5% during the third quarter, ending at 5,953.46 as political noise brought about by the alleged flood control corruption scandal spooked the local market. Foreign investors sold \$150mio during the quarter. Inflation remained low, averaging 1.4% for the past three months, which allowed the Bangko Sentral ng Pilipinas (BSP) to deliver two 25-bps cut in policy rates to 4.75% (from 5.25%) during their last two meetings. For the year, the BSP had cut policy rate by 1% citing low inflation and economic policy uncertainty resulting from possible slowdown in government spending and lower capital spending plans by the private sector. Gross domestic product for 2025 is now expected to be between 5.5%-6.5%, coming from previous forecast of 6-7%. Moving forward, market sentiment may remain cautious as investors wait for further developments on the flood control projects controversy. Also, investors wait for the implementing rules and regulations of the Konektadong Pinoy bill which will impact the telecommunications sector. Third quarter corporate earnings will also influence stock prices in the short term with trading range expected to be between 5,800 to 6,200.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity, equity and equity-linked constituents of the PSE and Such other tradeable investment outlets as may be allowed by the BSP. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
