INVESTMENT OBJECTIVE AND STRATEGY

The objective of the fund is to achieve long-term capital appreciation via an indexing strategy based on the Philippine Stock Exchange Index (PSEI) constituents, while maintaining a reasonable level of liquidity for investor requirements.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective Participants if the Fund is suited to his/her investment objectives and risk tolerance. Participants are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The Fund is suitable for investors with a longer-term investment horizon, have an aggressive risk profile, looking for higher returns compared to other investment outlets with shorter investment horizons, and willing to take on the pertinent risks.
- Participants/trustors are recommended to stay invested in the Fund for at least 5 years.

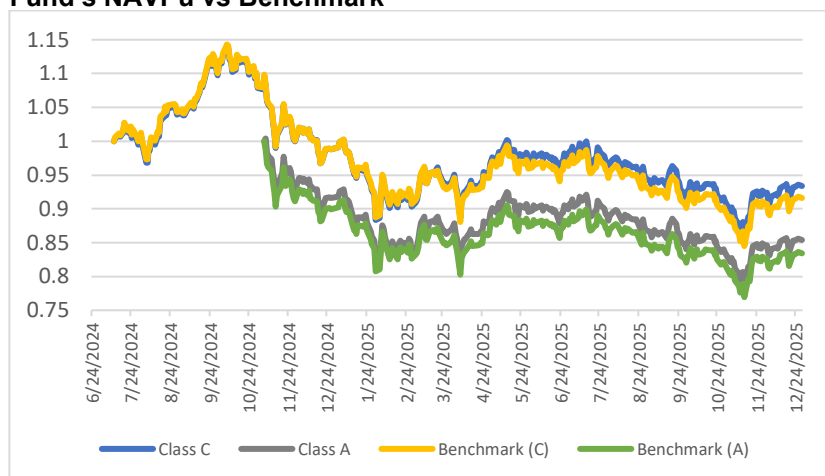

OUTLOOK AND STRATEGY

Market Review. The PSEi gained 1.67% during the fourth quarter to close at 6,052.92 and trimmed full year 2025 decline to -7.29%. Despite continuous foreign selling, the local bourse managed to hold above the 6,000 level as local investors supported the market. Among the sub-indices, the mining sector (+17%) and services sector (+11%) led the gainers while the Holdings and Industrial sectors both declined by 2% during the quarter. On the macro front, inflation remained low and averaged 1.7% while USDPHP exchange rate averaged 58.68 during the quarter. Third quarter GDP came in at 4%, lower than estimates and prompted the BSP to cut rates by 25bps in December. This was the fifth rate cut for the year and brought the key policy rate down to 4.5%. Corporate earnings for the third quarter were mostly in line with expectations, with same trends seen for the fourth quarter. Going forward, the PSEi may try to make a run to 6,400 level given reasonable valuations and as the local bourse play catch up with the other ASEAN markets. However, the risk of lower economic growth due to lower public spending coupled with low consumer and business sentiment may cap the market recovery.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
