Account Registration

Automatic Registration to My Sun Life Client Portal

All new Sun Life clients will be auto-registered to the My Sun Life Client Portal. An activation link will be sent to your e-mail, and you have **15 days** to activate your account.

In case the activation link is no longer valid, you may register to My Sun Life Client Portal through:

- 1. Client Care at sunlink@sunlife.com or (02) 8-849-9888 to request for a new activation link (you have 48 hours to activate)
- 2. Manual registration


Account Registration

Manual Registration to My Sun Life Client Portal

All new Sun Life clients may register online 3 days after receiving the first SMS or e-mail subscription confirmation. To register:

- 1. Go to www.sunlifefunds.com.
- 2. Click **Sign in** and a new window will appear. Then, click **Register now**.
- 3. Accomplish the registration form and submit.

The initial password will be sent directly to your registered e-mail address. You will need to click on the link provided to verify your registration. You also have 48 hours from the receipt of e-mail to activate your account.






Sun Life PH Mobile App

- 2. Complete the form to register.






Reminders







Via Bank - Cash/Check

Making additional investments via bank deposit is very convenient when done online:

- Deposit to SLAMCI account.
- 2. Select the fund and click Add Fund.
- For Client Portal, select Bank as mode of payment. For Mobile App, select Cash or Check as type of payment.
- 4. Upload proof of payment.
- 5. Submit


Additional Investments

Via Prosperity Card

You may use our PHP 1,000 and PHP 5,000-denominated Prosperity Cards to add to your peso-denominated funds.

- 1. Select the fund and click **Add Fund**.
- For Client Portal, select Prosperity Card as mode of payment. For Mobile App, select Prosperity Card as type of payment.
- Input card details.
- 4. Submit.

Important Note: You can invest up to three (3) cards at a time in Client Portal. For Mobile App, you can invest one (1) card at a time only.


The sales load fees are subject to 12% VAT and apply to all peso and dollar-denominated Sun Life Prosperity Funds except the Sun Life Prosperity Money Market Fund and Sun Life Prosperity Dollar Starter Fund. For the Achiever Funds, only the back-end option is allowed.

New fund transactions must meet the Fund's minimum initial investment amounts.




Investing in New Funds

Via Bank - Cash/Check

Buying new funds is similar to adding additional investments:

- Deposit to SLAMCI account.
- 2. Click any fund and select **Add Fund**.
- 3. Choose a new fund.
- 4. Upload proof of payment.
- 5. Accomplish the form and Submit.

Note that your investments are also subject to **sales load** (front-end or back-end).


Investing in New Funds

Via Prosperity Card

You may use our PHP 1,000 and PHP 5,000denominated Prosperity Cards to buy a new pesodenominated fund in the Client Portal.

- 1. Select any fund and click Add Fund.
- 2. Choose **Prosperity Card** as mode of payment.
- 3. Input card details.
- 4. Choose a new fund.
- 5. Accomplish the form and submit.

Important Note: You can invest up to three (3) cards at a time in Client Portal.

Full Redemptions

Full Redemption happens when all funds are claimed from a fund. Redeeming by shares (or units) is the recommended method to do this:

- Click Redeem Fund.
- 2. Choose **Shares (or Units)** as mode of redemption.
- 3. Check Redeem all shares (or Redeem all units).
- 4. Accomplish the form and submit.



Redemption Settlement

Redemptions may be claimed on the Funds' respective Settlement Dates:

Important Notes:

Daily cut-off is 12NN*.

Redemption transactions that will cause a fund to fall below the required maintaining balance will redeem the investment in full.

*In view of community quarantine, new cut-off time is **11AM** until further notice.





Fund Switches


Fund Switching is the process of redeeming your investments from a certain fund then using the redemption proceeds to subscribe to another fund. To switch:

- Click Switch Fund.
- 2. Accomplish the form and submit.

Switching from Money Market to a loaded fund?

For Client Portal: You may specify the Sales Load in the Remarks portion of the Switch Fund panel.

For Mobile App: E-mail <u>sunlink@sunlife.com</u> to confirm Sales Load. Please keep your contact numbers available for our Investor Services team to confirm the transaction.

Reminders

When switching, the **Source Fund** should still maintain the **Minimum Balances**.

When switching to a **New Destination Fund**, the switch amount should follow the **Minimum Initial Investment Amounts**.


When switching to an *Existing Destination Fund*, the switch amount should follow the *Minimum* Additional Investment Amounts.



Full Switching

Full Switching happens when all funds are transferred from a fund. Transferring by shares (or units) is the recommended method to do this:

- 1. Click Switch Fund.
- Choose Shares (or Units) as mode of redemption.
- Check Transfer all shares (or Transfer all units).
- Accomplish the form and submit.



Fund Switch Settlement

Funds will be transferred on their respective **Settlement Dates**:

Important Notes:

- 1. Switch order transactions that will cause the Source Fund to fall below the minimum balance will be pending until confirmed by the client, except in cases of full switch.
- 2. Under-Switching shall not be allowed to effectively maintain the minimum balance of the Fund.
- 3. Switching out from any of the three Achiever Funds is not allowed.



Subscribing to e-SOA

The e-SOA or Electronic Statement of Account is a digital version of your quarterly statement. This can be accessed through the My Sun Life Client Portal.

Subscribe to e-SOA in three easy steps:

- Log-in to your Client Portal account.
- 2. Click **Settings** at the left-hand panel and go to **Notification settings**.
- 3. Under Mutual fund, tick the Statement of Account (eSOA) checkbox and Update.



Once done, your changes will be saved. You are now subscribed to e-SOA. You will receive an e-mail confirming your subscription.

Viewing your e-SOA

 Log-in to your My Sun Life Client Portal account. At the left-hand panel, click All and you will see your summary of accounts.



2. Click your Mutual Fund account number(s) and click the **Statement of account** tab. Click **Download Statement** to access your e-SOAs.



e-SOA Facility

Important Reminders

- 1. Subscribing to e-SOA is free of charge.
- 2. By subscribing, you have chosen to receive your quarterly statement electronically. As such, the printed statement will no longer be sent to you.
- 3. The e-SOA facility is not available in the Mobile App at the moment.
- 4. Client Portal will contain your e-SOAs for the past two (2) years or a total of eight (8) quarters.
- 5. e-SOAs become available in the Client Portal only **after subscribing** to the facility. Previous statements that were printed and delivered to you will not be available for viewing in the portal.
